Commonwealth Swim Club, Inc. New Membership Categories, Eligibility, and Fees - 2009

1. **Family Membership.** Open to members of a family residing at a single address. The membership is normally held in the name of the head of the household. Members of a family who are entitled to use the corporation's facilities shall include: the member and the members spouse (or domestic partner), and

- a. The children, grandchildren, and great grandchildren of the member and/or the member's spouse, including foster children, grandchildren, and great grandchildren, wherever situated.
- b. The spouses of the children, grandchildren, and great grandchildren of the member and/or the member's spouse, wherever situated
- c. Any other legal or blood relatives of the member or the member's spouse who resides year-round at the member's address.

2. **Family Membership for New Members.** The Family Membership rate for new members of Commonwealth (who did not have a membership at Commonwealth in 2008) is \$389 for the 2009 season. New members may also prorate their 2009 dues if they join after the start of the season, according to the table above.

3. **Senior.** If either a permanent member or his/her spouse has attained the age of 60 years, and if the member elects **not to include in the membership** any children, grandchildren, great grandchildren, or other family members (besides the member's spouse), the member shall be entitled to a reduction in the basic annual membership dues. The Board of Directors shall establish a separate annual dues rate for senior citizen memberships. All other assessments and fees, including tennis fees, will be chargeable at the normal rate. Special senior citizen members are entitled to unrestricted purchase of guest passes and shall enjoy all other privileges and obligations of membership. Members electing special senior citizen status must submit evidence of qualifying age.

4. **Two Person.** If an **adult member** elects to include in their membership **only one other family member** (as defined in Article I, paragraph C of CSC Bylaws) the member shall be entitled to a reduction in the basic annual membership dues. The Board of Directors shall establish a separate annual dues rate for two-person memberships. All other assessments and fees, including tennis fees, will be chargeable at the normal rate. Special two-person members are entitled to unrestricted purchase of guest passes and shall enjoy all other privileges and obligations of membership.

5. **Limited Tennis Membership.** A member who has maintained active, membership for at least 15 years is eligible to elect a limited, family tennis membership. Limited tennis members and their eligible family members enjoy complete tennis and tennis-guest privileges, as well as all Club social privileges. However, limited tennis members and their families are not authorized general swimming privileges or swimming-guest privileges. The Board of Directors shall establish a separate annual dues rate for limited tennis members. Election of limited tennis membership is revocable; normal permanent membership may be elected in succeeding seasons

6. **Tennis Supplement.** An annual fee that allows a permanent member (with a Family, Two-person, or Senior rate) pays to allow them access to the club's tennis courts.

7. **Tennis Key Deposit.** Members who pay for a tennis supplement or a Limited Tennis Membership pay a one-time deposit for a key to the tennis courts.

Note: It is required that parent(s)/grandparent(s) must be members in good standing for their child(ren) to participate in pool activities such as the swim and dive teams.
